A bill to amend 1976 PA 451, entitled "The revised school code," by amending section 1285a (MCL 380.1285a), as added by 1996 PA 285.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1285a. (1) If a school district or intermediate school
- 2 district operates a child care center, AS DEFINED IN SECTION 1 OF

- 8 operated by a school district or intermediate school district is

- 10 the state fire marshal or other similar authority as provided in

- 13 (iii) WITHIN 3 MONTHS AFTER HE OR SHE BEGINS TO WORK IN THE

- 15 FICATION IN CARDIOPULMONARY RESUSCITATION AND BASIC FIRST AID

- 24 PHYSICAL DEVELOPMENT; SOCIAL DEVELOPMENT, INCLUDING POSITIVE
