THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 471. (1) The tax imposed by this act shall be adminis-
- 2 tered by the department. The department shall prescribe forms
- 3 for use by taxpayers and may promulgate rules for all of the

- 5 (a) The maintenance by taxpayers of records, books, and
