- 18 (e) Submitting SUBMITS to a public official of this state
- 19 or a political subdivision of this state for approval, a permit
- 20 or a plan for filing as a public record, a specification, a
- 21 report, or a land survey which THAT does not bear 1 or more
- 22 seals of a licensee as required by this article. This subdivi-
- 23 sion does not apply to a public work costing less than \$15,000.00
- 24 or a residential building containing not more than 3,500
- 25 square feet of calculated floor area. AS USED IN THIS SUBDIVI-
- 26 SION, "CALCULATED FLOOR AREA" MEANS THAT TERM AS DEFINED IN
- 27 SECTION 2012(2)(A).
