SENATE BILL NO. 387

(As passed the Senate November 1, 2001)

A bill to amend 1989 PA 24, entitled "The district library establishment act," by amending section 11 (MCL 397.181); and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11. (1) ALL OF THE FOLLOWING APPLY TO AN ELECTION OF
- 2 BOARD MEMBERS OF A DISTRICT LIBRARY UNLESS A SCHOOL DISTRICT IS A
- 3 PARTICIPATING MUNICIPALITY AND SUBSECTION (2) IMPOSES A DIFFERENT
- 4 REQUIREMENT:
- 5 (A) IF AN AGREEMENT PRESCRIBES ELECTED BOARD MEMBERS, THE
- 6 BOARD SHALL CONSIST OF 7 MEMBERS ELECTED AT LARGE FROM THE
- 7 DISTRICT.
- 8 (B) IF AN AGREEMENT PRESCRIBES ELECTED BOARD MEMBERS, A
- 9 PROVISIONAL BOARD OF 7 MEMBERS SHALL BE APPOINTED. THE MEMBERS

- 1 OF THE PROVISIONAL BOARD SHALL HOLD OFFICE UNTIL THEIR SUCCESSORS
- 2 ARE ELECTED AND QUALIFIED.
- 3 (C) THE FIRST ELECTION OF BOARD MEMBERS SHALL TAKE PLACE AT
- 4 THE FIRST GENERAL ELECTION HELD 140 DAYS OR MORE AFTER THE
- 5 APPOINTMENT OF THE FIRST MEMBER OF THE PROVISIONAL BOARD. THE 4
- 6 PERSONS RECEIVING THE MOST VOTES AT THE FIRST ELECTION FOR BOARD
- 7 MEMBERS SHALL HAVE 4-YEAR TERMS, AND THE 3 REMAINING PERSONS

- 11 (D) BOARD MEMBERS SHALL BE ELECTED ON NONPARTISAN BALLOTS.
- 12 (E) SUBJECT TO SUBDIVISION (F), A NOMINATION FOR THE OFFICE
- 13 OF BOARD MEMBER SHALL BE BY NONPARTISAN PETITIONS SIGNED BY REG-
- 14 ISTERED ELECTORS OF THE DISTRICT. THE NUMBER OF SIGNATURES SHALL
- 15 BE AS FOLLOWS:
- 16 (i) FOR A DISTRICT WITH A POPULATION OF LESS THAN 10,000,
- 17 NOT LESS THAN 6 OR MORE THAN 20.

- 22 HAVE HIS OR HER NAME PLACED ON THE BALLOT.
- 23 (G) A NOMINATING PETITION OR FILING FEE SHALL BE FILED WITH
- 24 THE CLERK OF THE LARGEST COUNTY NOT LATER THAN 4 P.M. OF THE DAY
- 25 110 DAYS BEFORE THE DATE OF THE ELECTION. THE COUNTY CLERK WITH
- 26 WHOM NOMINATING PETITIONS OR FILING FEES ARE FILED SHALL CERTIFY

- 1 THE NAMES OF THE CANDIDATES TO THE CLERK OF EVERY OTHER COUNTY IN
- 2 WHICH ALL OR PART OF A PARTICIPATING MUNICIPALITY IS LOCATED.
- 3 (H) A VACANCY IN THE OFFICE OF A BOARD MEMBER SHALL BE
- 4 FILLED UNTIL THE EXPIRATION OF THE VACATING BOARD MEMBER'S TERM
- 5 BY APPOINTMENT BY MAJORITY VOTE OF THE REMAINING BOARD MEMBERS.
- 6 HOWEVER, IF THE VACANCY OCCURS 140 OR MORE DAYS OR, IF A SCHOOL
- 7 DISTRICT IS A PARTICIPATING MUNICIPALITY, 13 OR MORE MONDAYS
- 8 BEFORE THE FIRST REGULARLY SCHEDULED ELECTION OF BOARD MEMBERS
- 9 THAT FOLLOWS THE BEGINNING OF THE TERM OF THE BOARD MEMBER VACAT-
- 10 ING OFFICE AND THAT TERM IS 4 YEARS, ALL OF THE FOLLOWING APPLY:
- 11 (i) THE VACANCY SHALL BE FILLED BY APPOINTMENT BY MAJORITY
- 12 VOTE OF THE REMAINING BOARD MEMBERS ONLY UNTIL THE NEXT DATE ON
- 13 WHICH THE TERM OF ANY BOARD MEMBER EXPIRES.
- 14 (ii) A BOARD MEMBER SHALL BE ELECTED AT THE REGULARLY SCHED-
- 15 ULED ELECTION OF BOARD MEMBERS NEXT FOLLOWING THE OCCURRENCE OF
- 16 THE VACANCY TO FILL THE VACANCY FOR THE REMAINDER OF THE TERM OF
- 17 THE BOARD MEMBER VACATING OFFICE.
- 18 (2) If a school district is a participating municipality,
- 19 the following apply to an election of board members for a dis-

- 21 (a) The first election of board members shall take place at
- 22 the same time as the first regularly scheduled election of school

- Enacting section 1. (1) This amendatory act takes effect

- (2) Section 10 of the district library establishment act,
