A bill to amend 1968 PA 251, entitled "Cemetery regulation act,"

by amending section 9 (MCL 456.529), as amended by 1982 PA 132.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 9. (1) The commissioner may hold hearings, administer
- 2 oaths, take testimony under oath, and request in writing the
- 3 appearance and testimony of witnesses, including the production
- 4 of books and records. Upon the refusal of a witness to appear,
- 5 testify, or submit books and records after a written request, the
- 6 commissioner or a party to a contested case may apply to the cir-
- 7 cuit court for Ingham county for a subpoena or a subpoena duces
- 8 tecum. The court shall issue a subpoena when reasonable grounds
- 9 are shown.
- 10 (2) When it appears to the commissioner that a person or
