HOUSE SUBSTITUTE FOR SENATE BILL NO. 801

A bill to amend 1984 PA 22, entitled "Michigan civilian conservation corps act," by amending section 12a (MCL 409.312a), as added by 1994 PA 394.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 12a. (1) The Michigan civilian conservation corps
- 2 endowment fund is created within the state treasury.
- 3 (2) The state treasurer may receive money or other assets
- 4 from any source for deposit into the endowment fund. The state
- 5 treasurer shall direct the investment of the endowment fund. THE
- 6 STATE TREASURER SHALL HAVE THE SAME AUTHORITY TO INVEST THE
- 7 ASSETS OF THE ENDOWMENT FUND AS IS GRANTED TO AN INVESTMENT FIDU-
- 8 CIARY UNDER THE PUBLIC EMPLOYEE RETIREMENT SYSTEM INVESTMENT ACT,
- **9** 1965 PA 314, MCL 38.1132 TO 38.1140l. The state treasurer shall
- 10 credit to the endowment fund interest and earnings from endowment
- 11 fund investments.
