SUBSTITUTE FOR SENATE BILL NO. 61

A bill to amend 1954 PA 116, entitled "Michigan election law,"
(MCL 168.1 to 168.992) by adding section 659.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 659. (1) IF A COUNTY, CITY, WARD, TOWNSHIP, OR VILLAGE
- 2 IS DIVIDED INTO 2 OR MORE ELECTION PRECINCTS, THE COUNTY, CITY,
- 3 WARD, TOWNSHIP, OR VILLAGE ELECTION COMMISSIONERS MAY, BY RESOLU-
- 4 TION, CONSOLIDATE THE ELECTION PRECINCTS FOR A PARTICULAR ELEC-
- 5 TION THAT IS NOT A GENERAL NOVEMBER ELECTION, A PRIMARY ELECTION
- 6 IMMEDIATELY BEFORE A GENERAL NOVEMBER ELECTION, OR OTHER STATE-
- 7 WIDE OR FEDERAL ELECTION. IN MAKING THE DETERMINATION TO CONSOL-
- 8 IDATE ELECTION PRECINCTS FOR A PARTICULAR ELECTION, THE ELECTION
- 9 COMMISSION SHALL TAKE INTO CONSIDERATION THE NUMBER OF CHOICES
- 10 THE VOTER MUST MAKE, THE PERCENTAGE OF REGISTERED VOTERS WHO
- 11 VOTED AT THE LAST SIMILAR ELECTION IN THE JURISDICTION, AND THE

- 1 INTENSITY OF THE INTEREST OF THE ELECTORS IN THE JURISDICTION

- 16 ELECTION. NOTICE MAY BE PROVIDED BY MAIL OR OTHER METHOD
- 17 DESIGNED TO PROVIDE ACTUAL NOTICE TO THE REGISTERED ELECTORS.
- (B) POST A WRITTEN NOTICE AT EACH ELECTION PRECINCT POLLING 18
- 19 PLACE STATING THE LOCATION OF THE CONSOLIDATED ELECTION PRECINCT
- 20 POLLING PLACE.
- 21 (4) IF A COUNTY, CITY, WARD, TOWNSHIP, OR VILLAGE CONSOLI-
- 22 DATES ELECTION PRECINCTS UNDER THIS SECTION, EACH AFFECTED ELEC-
- 23 TION PRECINCT SHALL BE TREATED AS A WHOLE UNIT AND SHALL NOT BE
- 24 DIVIDED DURING THE CONSOLIDATION.
