A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending sections 90a, 90b, 90c, 90d, and 90e (MCL 750.90a, 750.90b, 750.90c, 750.90d, and 750.90e), as added by 1998 PA 238.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
