# **SENATE BILL No. 838**

November 29, 2001, Introduced by Senator GARCIA and referred to the Committee on Finance.

A bill to amend 1995 PA 266, entitled

"An act to authorize and regulate credit card transactions involving local units of government, including the use of credit cards by officers and employees of local units of government; and to provide for powers and duties of certain state and local agencies, officers, and employees,"

by amending sections 1 and 2 (MCL 129.241 and 129.242), section 1 as amended by 2000 PA 169.

#### THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1. As used in this act:
- (a) "Budget" means a plan of financial operation for a given
- 3 period of time, including an estimate of all proposed expendi-
- 4 tures from the funds of a local unit and the proposed means of
- 5 financing the expenditures. As used in section 4(1), budget does
- 6 not include any of the following:
  - (i) A fund for which the local unit acts as a trustee or
- 8 agent.
