THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 10. (1) The pledge and lien on distributable aid cre-
- 2 ated by this act in favor of the holder of a distributable aid
- 3 obligation may be on a parity with any pledge or application of
- 4 distributable aid as security for obligations of a municipality
- 5 under a contract or proceedings authorized by law after July 14,
- 6 1981 permitting the pledge or application of distributable aid
- 7 regardless of whether that contract or proceedings are subse-
- 8 quently declared invalid, illegal, unenforceable, disaffirmed, or
- 9 otherwise terminated in whole or in part. However, any

- 2 the distributable aid respecting these obligations shall be paid,

- 1 (3) A municipality may pledge and assign distributable aid
- 2 for other obligations of the municipality authorized by law after
