SUBSTITUTE FOR SENATE BILL NO. 1201

A bill relative to the reporting of the issuance of certain debt and securities; and to prescribe powers and duties of certain departments, agencies, officials, and employees.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. This act shall be known and may be cited as the
- 2 "agency financing reporting act".
- 3 Sec. 3. As used in this act:
- 4 (a) "Agency" means this state, a state authority, agency,
- 5 funds commission, board, or department of this state. Agency
- 6 also includes a municipality issuing debt exempt from the provi-
- 7 sions of the revised municipal finance act, 2001 PA 34,
- 8 MCL 141.2101 to 141.2821, or the provisions of the revenue bond
- 9 act of 1933, 1933 PA 94, MCL 141.101 to 141.140.
- 10 (b) "Department" means the department of treasury.

- 1 (c) "Municipality" means a county, township, city, village,
- 2 school district, intermediate school district, community college

- **6** (d) "Security" means an evidence of debt such as a bond,
- 7 note, contract, obligation, refunding obligation, certificate of
- 8 indebtedness, or other similar instrument issued by an agency,
- 9 which pledges payment of the debt by the agency from an identi-
- 10 fied source of revenue. Security does not include the items
- 11 described in section 105 of the revised municipal finance act,
- 12 2001 PA 34, MCL 141.2105.
- 13 Sec. 5. Before issuing a security, an agency shall file
- 14 with the department a statement of intent to issue a security on
- 15 a form and in a manner prescribed by the department.
- 16 Sec. 7. (1) Within 15 business days of completing the issu-
- 17 ance of any security, an agency shall file all of the following
- 18 with the department in a form and manner prescribed by the
- **19** department:
- 20 (a) A copy of the security.
- 21 (b) A proof of publication of the notice of sale, if
- 22 applicable.
- 23 (c) A copy of the award resolution including a detail of the
- 24 annual interest rate and call features on the security, if any.
- 25 (d) A copy of the legal opinion regarding the legality and
- 26 tax status of the security.

- 1 (e) A copy of the notice of rating of the security received
- 2 from a recognized rating agency, if any.
- 3 (f) A copy of the resolution or ordinance authorizing the
- issuance of the security. 4
- 5 (g) A copy of the official statement, if any.
- 6 (2) The failure to comply with subsection (1) does not
- 7 invalidate any of the securities reported under this act.
