- 17 TENSION AND COMPRESSION FORCES ANTICIPATED DURING THE DRILLING,
- 18 CONSTRUCTION, AND OPERATION OF THE WELL.
- 19 (iv) MATERIALS USED FOR CASING, JOINTS, SCREENS, AND OTHER
- 20 PERMANENT WELL EQUIPMENT SHALL BE CHEMICALLY COMPATIBLE WITH
- 21 SOILS AND GROUNDWATER ANTICIPATED DURING THE DRILLING, CONSTRUC-
- 22 TION, AND OPERATION OF THE WELL.
- 23 (v) A GEOTECHNICAL WELL IN WHICH THE BOREHOLE DIAMETER
- 24 EXCEEDS THE OUTSIDE CASING DIAMETER SHALL BE GROUTED BY FILLING
- 25 THE ANNULAR SPACE BETWEEN THE CASING AND THE BOREHOLE WALL FROM
- 26 THE BOTTOM OF THE ANNULAR SPACE TO THE SURFACE AS FOLLOWS:

- 1 (A) ANY SECTION OF A GEOTECHNICAL WELL THAT PENETRATES
- 2 BEDROCK SHALL BE GROUTED WITH CEMENT GROUT.
- 3 (B) ANY SECTION OF A GEOTECHNICAL WELL THAT PENETRATES GLA-
- 4 CIAL DRIFT OR OTHER UNCONSOLIDATED MATERIALS SHALL BE GROUTED

- 9 OVERSIZE WITH RESPECT TO THE BOREHOLE DIAMETER SHALL BE GROUTED
- 10 BY INTRODUCING BENTONITE GRANULES CONTINUALLY ALONG THE OUTSIDE
- 11 OF THE CASING AS THE CASING IS ADVANCED.
- 12 (F) THE TOP OF THE CASING IN A GEOTECHNICAL WELL SHALL BE
- 13 SEALED IN SUCH MANNER THAT IT EXCLUDES PRECIPITATION, SURFACE
- 14 WATER, DIRT, OR OTHER FOREIGN MATERIALS FROM ENTERING THE WELL.
- 15 (G) THE TOP OF THE CASING IN A GEOTECHNICAL WELL SHALL BE
- 16 PROTECTED FROM DAMAGE BY APPROPRIATE MEASURES.
- 17 (H) THE CASING IN A GEOTECHNICAL WELL SHALL BE SECURED IN A
- 18 MANNER THAT PREVENTS UNAUTHORIZED ENTRY INTO THE WELL.
- 19 (2) THE DEPARTMENT MAY GRANT AN EXCEPTION TO A PROVISION OF
- 20 SUBSECTION (1) IF THE OWNER OF THE GEOTECHNICAL WELL DEMONSTRATES
- 21 TO THE SATISFACTION OF THE DEPARTMENT THAT AN ALTERNATIVE METHOD
- 22 OR MATERIAL SATISFIES THE INTENT OF SUBSECTION (1). IF THE
- 23 DEPARTMENT DOES NOT RESPOND TO A REQUEST FOR AN EXCEPTION WITHIN
- 24 10 BUSINESS DAYS OF RECEIPT OF THE REQUEST, THE REQUEST SHALL BE
- 25 CONSIDERED GRANTED.
- 26 SEC. 14103. (1) THE OWNER OF A GEOTECHNICAL WELL SHALL PLUG
- 27 THE WELL WITHIN 1 YEAR AFTER THE WELL CEASES TO BE USED FOR ITS

- 1 INTENDED PURPOSE. A GEOTECHNICAL WELL SHALL BE PLUGGED IN
- 2 COMPLIANCE WITH ALL OF THE FOLLOWING:
- 3 (A) A GEOTECHNICAL WELL SHALL BE PLUGGED IN A MANNER THAT
- 4 PREVENTS THE MOVEMENT OF CONTAMINANTS FROM THE SURFACE TO A SUB-
- 5 SURFACE STRATUM OR FROM 1 SUBSURFACE STRATUM TO ANOTHER, AND PRE-
- 6 VENTS THE FLOW OF GROUNDWATER FROM 1 STRATUM INTO ANOTHER OR TO

- 26 SHALL BE PLUGGED PURSUANT TO SUBDIVISIONS (B) AND (C).

- 1 (E) NOTWITHSTANDING ANY PROVISION OF THIS SUBSECTION,
- 2 GRAVEL, SAND, STONE AGGREGATE, OR FLUID LOSS AGENTS MAY BE USED
- 3 FOR PLUGGING THAT SECTION OF A GEOTECHNICAL WELL THAT PENETRATES
- 4 LOST CIRCULATION ZONES.
- 5 (F) ONLY CEMENT OR CONCRETE GROUT SHALL BE USED TO PLUG GEO-
- 6 TECHNICAL WELLS THAT DISCHARGE GASES FROM THE SUBSURFACE OR THAT
- 7 ENCOUNTER GROUNDWATER UNDER ARTESIAN PRESSURE. PRECAUTIONS SHALL
- 8 BE TAKEN TO PREVENT GAS OR GROUNDWATER UNDER ARTESIAN PRESSURE
- 9 FROM CUTTING THE CEMENT AND REACHING ANOTHER STRATUM OR THE

- 11 (G) PLUGGING MATERIALS FOR GEOTECHNICAL WELLS SHALL BE

- 23 ING IN THE CASING OR BOREHOLE, UNTIL THE WELL IS FILLED TO THE
- 24 DEPTH PRESCRIBED IN THIS SECTION.
- 25 (H) UPON COMPLETION OF PLUGGING, THERE SHALL BE NO OPEN,
- 26 UNPLUGGED ANNULAR SPACE BETWEEN CASINGS OR BETWEEN A CASING AND

- 1 THE BOREHOLE, AND THERE SHALL BE NO OPEN, UNPLUGGED SPACE INSIDE
- 2 A CASING OR IN THE BOREHOLE.
- 3 (I) CASING MAY BE REMOVED FROM A GEOTECHNICAL WELL PROVIDED
- 4 ALL REQUIREMENTS OF THIS SECTION ARE MET.
- 5 (2) THE DEPARTMENT MAY GRANT AN EXCEPTION TO A PROVISION OF
- 6 SUBSECTION (1) IF THE OWNER OF A GEOTECHNICAL WELL DEMONSTRATES
- 7 TO THE SATISFACTION OF THE DEPARTMENT THAT AN ALTERNATIVE METHOD
- 8 OR MATERIAL SATISFIES THE INTENT OF SUBSECTION (1). IF THE
- 9 DEPARTMENT DOES NOT RESPOND TO A REQUEST FOR AN EXCEPTION WITHIN
- 10 10 BUSINESS DAYS OF RECEIPT OF THE REQUEST, THE REQUEST SHALL BE
- 11 CONSIDERED GRANTED.
- 12 SEC. 14104. IF THE DEPARTMENT DETERMINES THAT AN OWNER OF A
- 13 GEOTECHNICAL WELL HAS FAILED OR NEGLECTED TO CASE, SEAL, OPERATE,
- 14 REPAIR, OR PLUG THE GEOTECHNICAL WELL PURSUANT TO THIS PART OR
- 15 THE RULES PROMULGATED UNDER THIS PART, THE DEPARTMENT SHALL GIVE
- 16 NOTICE OF THE DETERMINATION TO THE OWNER. IF THE OWNER FAILS TO
- 17 CORRECT THE SPECIFIED CONDITIONS WITHIN 60 DAYS AFTER SERVICE OF
- 18 NOTICE, THE DEPARTMENT MAY ENTER INTO OR UPON ANY PRIVATE OR
- 19 PUBLIC PROPERTY ON WHICH THE WELL IS LOCATED, AND ACROSS ANY PRI-
- 20 VATE OR PUBLIC PROPERTY TO REACH THE WELL, AND REPAIR OR CORRECT
- 21 THE SPECIFIED CONDITION, AND THE OWNER IS LIABLE FOR ALL EXPENSES

- 21 (3) CIVIL FINES COLLECTED UNDER THIS SECTION SHALL BE FOR-

- 24 SEC. 14108. A PERSON WHO VIOLATES THIS PART IS GUILTY OF A
