- 3 SEC. 2805. A JUDGMENT LIEN IS EXTINGUISHED WHEN 1 OR MORE
- 4 OF THE FOLLOWING EVENTS OCCUR:
- 5 (A) THE JUDGMENT EXPIRES.
- 6 (B) THE JUDGMENT CREDITOR FILES A RELEASE WITH THE REGISTER
- 7 OF DEEDS.
- 8 (C) A TRUE COPY OF A SATISFACTION OF JUDGMENT IS FILED WITH
- 9 THE REGISTER OF DEEDS.
- 10 (D) A TRUE COPY OF A COURT ORDER THAT DIRECTS THE RELEASE OF
- 11 THE LIEN IS FILED WITH THE REGISTER OF DEEDS.
- 12 SEC. 2806. A JUDGMENT LIEN MAY BE FORECLOSED BY SALE BY AN
- 13 OFFICER APPOINTED BY A COURT AND IN THE SAME MANNER AS THE SALE
- 14 OF ANY REAL ESTATE TAKEN ON EXECUTION PURSUANT TO SECTIONS 6041,
- 15 6042, 6044 TO 6046, AND 6052 TO 6072.
- 16 SEC. 2807. A JUDGMENT LIEN IS IN ADDITION TO AND SEPARATE
- 17 FROM ANY OTHER REMEDY OR INTEREST CREATED BY LAW OR CONTRACT.
