- 3 TION 31(5) ARE MET, THE RATE IMPOSED UNDER SECTION 31 AND
- 4 ADJUSTED UNDER THIS ACT SHALL BE REDUCED BY 0.2 PERCENTAGE
- 5 POINTS.
- (2) THE DEPARTMENT SHALL ANNUALIZE THE RATE UNDER THIS SEC-
- 7 TION AS NECESSARY, AND THE APPLICABLE ANNUALIZED RATE SHALL BE
- 8 IMPOSED.
