- 3 RATE IMPOSED UNDER SECTION 31 AND ADJUSTED UNDER THIS ACT SHALL
- 4 BE REDUCED BY 0.2 PERCENTAGE POINTS. ON THE TENTH JANUARY 1 FOL-
- 5 LOWING DECEMBER 31, 2000 FOR WHICH THE CONDITIONS UNDER SECTION
- 6 31(5) ARE MET, THE RATE IMPOSED UNDER SECTION 31 AND ADJUSTED
- 7 UNDER THIS ACT SHALL BE REDUCED TO ZERO.
- 8 (2) THE DEPARTMENT SHALL ANNUALIZE THE RATE UNDER THIS SEC-
