A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 80163 (MCL 324.80163), as added by 1995 PA 58.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 80163. (1) A PERSON SHALL NOT SET, PLACE, ERECT, OR
- 2 CAUSE TO BE SET, PLACED, OR ERECTED, OR USE AN ANCHORED RAFT AT
- 3 ANY TIME UPON THE WATERS OF WHICH THE STATE HAS JURISDICTION,
- 4 UNLESS THE NAME AND ADDRESS OF THE OWNER IS AFFIXED TO EACH SIDE
- 5 OF THE OUTSIDE OF THE ANCHORED RAFT IN LEGIBLE LETTERS NOT LESS
- 6 THAN 2 INCHES IN HEIGHT. THE LETTERS SHALL BE READILY VISIBLE
- 7 AND CONSIST OF MATERIALS THAT ARE NOT SOLUBLE IN WATER.
- 8 (2) PLACING THE OWNER'S NAME AND ADDRESS ON A PIECE OF WOOD,
- 9 PLASTIC, OR OTHER MATERIAL AND AFFIXING THAT PIECE OF MATERIAL TO

- 3 (3) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A MIS-

- 5 OR A FINE OF NOT LESS THAN \$100.00 OR MORE THAN \$500.00, OR BOTH,

- 12 (5) Whenever, in the opinion of the department, an anchored
- 13 raft presents a hazard to navigation, the department may order
