February 13, 2001, Introduced by Reps. Vear, Spade and Raczkowski and referred to the Committee on Criminal Justice.

A bill to amend 1931 PA 328, entitled

"The Michigan penal code,"

by amending sections 81 and 81a (MCL 750.81 and 750.81a), section 81 as amended by 2000 PA 462 and section 81a as amended by 1999 PA 270.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
