THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 40. (1) The right of a person to a pension, an annui-
- 2 ty, a retirement allowance, any optional benefit, any other right

- 4 act, the various funds created by this act, and all money and
- 5 investments and income of the funds, are exempt from any state,
