- 1 SEC. 21797. (1) THE DEPARTMENT SHALL ADMINISTER A GRANT
- 2 PROGRAM FOR BOTH OF THE FOLLOWING:
- 3 (A) AN INDIVIDUAL WHO IS IN TRAINING TO BECOME A REGISTERED
- 4 PROFESSIONAL NURSE, LICENSED PRACTICAL NURSE, OR NURSE'S AIDE.

- 6 NURSE, OR NURSE'S AIDE WHO IS EMPLOYED AT A NURSING HOME IN THIS

- 18 (B) "LICENSED PRACTICAL NURSE" MEANS THE PRACTICE OF NURSING
- 19 AS A LICENSED PRACTICAL NURSE AS THAT TERM IS DEFINED IN SECTION
- **20** 17201.
- 21 (C) "REGISTERED PROFESSIONAL NURSE" MEANS THAT TERM AS
- 22 DEFINED IN SECTION 17201.
