## **HOUSE BILL No. 4453**

A bill to amend 1979 PA 218, entitled "Adult foster care facility licensing act," (MCL 400.701 to 400.737) by adding section 34a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 34A. (1) IN ADDITION TO THE RESTRICTIONS PRESCRIBED IN

- 17 (8) AN INDIVIDUAL WHO KNOWINGLY PROVIDES FALSE INFORMATION
- 18 REGARDING A CRIMINAL CONVICTION ON A STATEMENT DESCRIBED IN SUB-
- 19 SECTION (5)(B)(i) IS GUILTY OF A MISDEMEANOR, PUNISHABLE BY
- 20 IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR A FINE OF NOT MORE THAN

- 22 (9) AN ADULT FOSTER CARE FACILITY SHALL USE CRIMINAL HISTORY
- 23 RECORD INFORMATION OBTAINED UNDER SUBSECTION (4) OR (5) ONLY FOR
- 24 THE PURPOSE OF EVALUATING AN INDIVIDUAL'S QUALIFICATIONS FOR
