- 2 AN INSPECTION REPORT ISSUED BY AN AUTHORIZED REPRESENTATIVE OF
- 3 THE DEPARTMENT OR A LOCAL HEALTH DEPARTMENT AFTER THE MOST RECENT
- 4 COMPLIANCE INSPECTION CONDUCTED UNDER THIS ACT, THE OWNER OR
- 5 OPERATOR OF A FOOD SERVICE ESTABLISHMENT SHALL COMPLY WITH
- 6 SUBSECTION (2).
- 7 (2) UPON THE REQUEST OF A CUSTOMER, THE OWNER OR OPERATOR OF
- 8 A FOOD SERVICE ESTABLISHMENT SHALL PROVIDE THE CUSTOMER WITH A
- 9 COPY OF THE INSPECTION REPORT DESCRIBED IN SUBSECTION (1).
