- 2 (3), A HOME FOR THE AGED SHALL ASSURE THAT EACH OF ITS RESIDENTS
- 3 IS VACCINATED FOR INFLUENZA ANNUALLY BETWEEN NOVEMBER 15 AND
- 4 DECEMBER 15. A HOME FOR THE AGED SHALL ASSURE THAT A RESIDENT
- 5 ADMITTED AFTER DECEMBER 15, BUT BEFORE APRIL 1 OF THE FOLLOWING
- 6 YEAR, IS VACCINATED FOR INFLUENZA AT THE TIME OF ADMISSION TO THE
