A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 411t.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 5 INQUIRY AS TO WHETHER THE INDIVIDUAL IS A MINOR, IS GUILTY OF A
- 6 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 6 MONTHS
- 7 OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (2) A HOTEL OR BED AND BREAKFAST MAY RENT OR LEASE A HOTEL
- 9 ROOM OR A BED AND BREAKFAST ROOM TO A MINOR IF A PARENT OR
- 10 GUARDIAN OF THE MINOR DOES EITHER OF THE FOLLOWING:

- 23 (C) "DILIGENT INQUIRY" MEANS A DILIGENT GOOD FAITH EFFORT TO
- 24 DETERMINE THE AGE OF AN INDIVIDUAL, THAT INCLUDES AT LEAST AN
- 25 EXAMINATION OF AN OFFICIAL MICHIGAN OPERATOR'S OR CHAUFFEUR'S
- 26 LICENSE, AN OFFICIAL MICHIGAN PERSONAL IDENTIFICATION CARD, OR
- 27 ANY OTHER BONA FIDE PICTURE IDENTIFICATION THAT ESTABLISHES THE
