## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 151D. (1) THE MONEY IN THE JUROR COMPENSATION REIM-
- 2 BURSEMENT FUND SHALL BE DISTRIBUTED EACH YEAR AS PROVIDED IN THIS
- 3 SECTION.
- 4 (2) EACH COURT FUNDING UNIT SHALL SUBMIT AN ANNUAL REPORT TO
- 5 THE STATE COURT ADMINISTRATOR, FOR EACH COURT FOR WHICH IT IS A
- 6 FUNDING UNIT, GIVING THE TOTAL OF COMPENSATION PAYMENTS MADE TO
- 7 JURORS, EXCLUDING TRAVEL REIMBURSEMENT, UNDER SECTION 1344. IF
- 8 ANY OF THE JUROR COMPENSATION PAYMENTS INCLUDED IN THAT TOTAL
- 9 AMOUNT WERE IN EXCESS OF THE STATUTORY MINIMUM AMOUNT PRESCRIBED
- 10 IN SECTION 1344, THE REPORT ALSO SHALL INCLUDE THE TOTAL AMOUNT
  - 11 PAID TO JURORS IN EXCESS OF THAT STATUTORY MINIMUM.

- 16 THE STATUTORY MINIMUM, BY THE TOTAL AMOUNT DETERMINED UNDER SUB-
- 17 DIVISION (A). THE RESULT REPRESENTS THE PERCENTAGE OF THE MONEY
- 18 IN THE FUND TO WHICH THAT COURT FUNDING UNIT IS ENTITLED.
- 19 (C) PAY THE TOTAL AMOUNT AVAILABLE IN THE FUND, AS DETER-
- 20 MINED UNDER SUBSECTION (3), TO ALL COURT FUNDING UNITS ACCORDING
- 21 TO THE PERCENTAGES DETERMINED UNDER SUBDIVISION (B).
- 22 (5) IT IS INTENDED THAT THE PAYMENTS MADE UNDER SUBSECTION
- 23 (4) ON APRIL 1, 2003 SHALL OFFSET EXPENSES INCURRED BY COURT
- 24 FUNDING UNITS FOR COSTS IN ADAPTING TO THE CHANGES IN THE STATU-
- 25 TORY MINIMUM RATE FOR JUROR COMPENSATION AS IMPLEMENTED BY THE
- 26 2001 AMENDATORY ACT THAT AMENDED SECTION 1344.
