THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 147b. (1) A person is guilty of ethnic FELONIOUS
- 2 intimidation if that person maliciously, and with specific intent
- 3 to intimidate or harass another person because of that person's
- 4 race, color, religion, gender, SEXUAL ORIENTATION, or national
- 5 origin, does any of the following:
- 6 (a) Causes physical contact with another person.
- 7 (b) Damages, destroys, or defaces any real or personal prop-
- 8 erty of another person.

- 1 (c) Threatens, by word or act, to do an act described in
- 2 subdivision (a) or (b), if there is reasonable cause to believe
- 3 that an act described in subdivision (a) or (b) will occur.
- 4 (2) Ethnic FELONIOUS intimidation is a felony punishable
- 5 by imprisonment for not more than 2 years, or by a fine of not
- 6 more than \$5,000.00, or both.
- 7 (3) A TERM OF IMPRISONMENT IMPOSED FOR FELONIOUS INTIMIDA-
- 8 TION SHALL BE SERVED IN ADDITION TO, CONSECUTIVE WITH, AND BEFORE
- 9 A TERM OF IMPRISONMENT IMPOSED FOR ANY OTHER FELONY OR ATTEMPTED
- 10 FELONY CONVICTION THAT ARISES OUT OF THE SAME TRANSACTION OR

- 13 (4) Regardless of the existence or outcome of any
- 14 criminal prosecution, a person who suffers injury to his or her

- 16 FELONIOUS intimidation may bring a civil cause of action against
- 17 the person who commits the offense to secure an injunction,
- 18 actual damages, including damages for emotional distress, or
- 19 other appropriate relief. A plaintiff who prevails in a civil
- 20 action brought pursuant to UNDER this section may recover both
- 21 of the following:
- 22 (a) Damages in the amount of 3 times the actual damages
- 23 described in this subsection or \$2,000.00, whichever is greater.
