- 6 AS NECESSARY.
- 7 (B) MAKE AVAILABLE TO ALL SCHOOL DISTRICTS, INTERMEDIATE
- 8 SCHOOL DISTRICTS, AND PUBLIC SCHOOL ACADEMIES A MODEL LOCAL
- 9 POLICY CONCERNING ADMINISTRATION OF MEDICATIONS TO PUPILS AT
