- 17 TRICT TO BE FILLED BY ELECTION IN 2002, THE TERM OF OFFICE OF THE
- 18 JUDGE FOR THAT ELECTION ONLY SHALL BE 4 YEARS.

- 27 next greatest number of votes shall be 6 years.
