A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 3938.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3938. (1) THE COMMISSIONER SHALL PREPARE AND BEGINNING
- 2 JULY 1, 2002 AND ANNUALLY THEREAFTER PUBLISH A CONSUMER GUIDE TO
- 3 LONG-TERM CARE INSURANCE AS PROVIDED IN THIS SECTION.
- 4 (2) THE CONSUMER GUIDE TO LONG-TERM CARE INSURANCE SHALL
- 5 CONTAIN A COST AND BENEFIT COMPARISON OF EACH LONG-TERM CARE
- 6 INSURANCE POLICY SOLD IN THIS STATE AND SHALL INCLUDE THE
- 7 TOLL-FREE TELEPHONE NUMBER AT THE OFFICE OF FINANCIAL AND INSUR-
- 8 ANCE SERVICES THAT CONSUMERS MAY CALL TO MAKE REQUESTS FOR THE
- 9 CONSUMER GUIDE AND MAKE INQUIRIES AND COMPLAINTS ABOUT LONG-TERM
- 10 CARE INSURANCE POLICIES.

- 9 PUBLIC THE EXISTENCE OF THE ANNUAL CONSUMER GUIDE. THE COMMIS-
- 10 SIONER SHALL DISTRIBUTE THE GUIDE TO MEMBERS OF THE PUBLIC UPON
- 11 REQUEST AND SHALL PROVIDE ACCESS TO THE CONSUMER GUIDE THROUGH
- 12 THE INTERNET.
