## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1707. (1) THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCA-
- 2 TION IS CREATED WITHIN THE DEPARTMENT.
- 3 (2) THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCATION SHALL
- 4 REVIEW AT LEAST ALL OF THE FOLLOWING MATTERS RELATING TO SPECIAL

  (A) THE COSTS OF SPECIAL EDUCATION PROGRAMS AND SERVICES

- 19 (5) THE MEMBERS FIRST APPOINTED TO THE BLUE RIBBON COMMITTEE
- 20 FOR SPECIAL EDUCATION SHALL BE APPOINTED WITHIN 30 DAYS AFTER THE
- 21 EFFECTIVE DATE OF THIS SECTION.
- 22 (6) IF A VACANCY OCCURS ON THE BLUE RIBBON COMMITTEE FOR
- 23 SPECIAL EDUCATION, THE GOVERNOR SHALL APPOINT A REPLACEMENT IN

- 3 (8) THE FIRST MEETING OF THE BLUE RIBBON COMMITTEE FOR SPE-
- 4 CIAL EDUCATION SHALL BE CALLED BY THE GOVERNOR. AT THE FIRST
- 5 MEETING, THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCATION SHALL
- 6 ELECT FROM AMONG ITS MEMBERS A CHAIRPERSON AND OTHER OFFICERS AS
- 7 IT CONSIDERS NECESSARY OR APPROPRIATE. AFTER THE FIRST MEETING,
- 8 THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCATION SHALL MEET AT
- 9 LEAST QUARTERLY, OR MORE FREQUENTLY AT THE CALL OF THE CHAIR-

- 20 (11) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF,
- 21 OR RETAINED BY THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCATION IN
- 22 THE PERFORMANCE OF AN OFFICIAL FUNCTION IS SUBJECT TO THE FREEDOM
- 23 OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246.
- 24 (12) MEMBERS OF THE BLUE RIBBON COMMITTEE FOR SPECIAL EDUCA-
- 25 TION SHALL SERVE WITHOUT COMPENSATION. HOWEVER, MEMBERS OF THE
- 26 BLUE RIBBON COMMITTEE FOR SPECIAL EDUCATION MAY BE REIMBURSED FOR

- 1 THEIR ACTUAL AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE
- 2 OF THEIR OFFICIAL DUTIES AS MEMBERS.
