HOUSE BILL No. 5019

July 11, 2001, Introduced by Rep. Bradstreet and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1204a (MCL 380.1204a), as amended by 1996 PA 159, and by adding section 1204b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1204a. (1) In addition to the requirements specified
- 2 in section 1280 for accreditation under that section, if the
- 3 board of a school district wants all of its schools to be accred-
- 4 ited under section 1280, the board shall prepare and submit to
- 5 the state board not later than September 1 each year, and shall
- 6 provide that each school in the school district distributes to
- 7 the public at an open meeting not later than October 15 each
- 8 year, an annual educational report. The annual educational
- 9 report shall include, but is not limited to, all of the following
- 10 information for each public school in the school district:

- 16 ment based upon the results of any locally-administered student

- 20 MICHIGAN EDUCATIONAL ASSESSMENT PROGRAM (MEAP) TESTS OR ANY OTHER
- 21 STATEWIDE ASSESSMENT TESTS, A SCHOOL SHALL LIMIT THE RESULTS IT
- 22 REPORTS TO THE RESULTS ATTAINED BY PUPILS WHO HAVE BEEN ENROLLED
- 23 IN THE SCHOOL DISTRICT FOR AT LEAST 1 FULL SCHOOL YEAR.
- 24 (e) For the year in which the report is filed and the previ-
- 25 ous school year, the district pupil retention report as defined

- 18 (iii) The number and percentage of pupils enrolled in the
- 19 school who were enrolled in at least 1 college level equivalent
- 20 course during the immediately preceding school year, disaggre-
- 21 gated by grade level.
- (iv) The number and percentage of pupils described in sub-
- 23 paragraph (iii) who took a college level equivalent credit
- 24 examination.
- (v) The number and percentage of pupils described in sub-
- **26** paragraph (iv) who achieved a score on a college level equivalent

- 1 credit examination that is at or above the level recommended by
- 2 the testing service for college credit.
- 3 (h) A comparison with the immediately preceding school year
- 4 of the information required by subdivisions (a) through (g).
- 5 (2) At least annually, the department shall prepare and
- 6 submit to the legislature a report of the information described
- 7 in subsection (1)(g), aggregated for statewide and intermediate
- 8 school district totals, using the information submitted by school
- 9 districts.
- 10 (3) The state board shall prepare and make available to
- 11 school districts suggestions for accumulating the information
- 12 listed in subsection (1) and a model annual educational report
- 13 for school districts to consider in the implementation of this

- 16 course" and "college level equivalent credit examination" mean

- 19 ERAL PUBLIC THE SCORES ACHIEVED BY PUPILS OF A SCHOOL DISTRICT ON
- 20 MICHIGAN EDUCATIONAL ASSESSMENT PROGRAM (MEAP) TESTS OR OTHER
- 21 STATEWIDE ASSESSMENTS, THE STATE BOARD, THE DEPARTMENT, OR THE
- 22 SUPERINTENDENT OF PUBLIC INSTRUCTION SHALL REPORT ONLY THE SCORES
- 23 ACHIEVED BY PUPILS WHO HAVE BEEN ENROLLED IN THE SCHOOL DISTRICT
- 24 FOR AT LEAST 1 FULL SCHOOL YEAR.
