- 3 CAUSES ANY PHYSICAL INJURY TO THAT OTHER INDIVIDUAL IS GUILTY OF
- 4 A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR
- 5 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH:
- 6 (A) THE OTHER INDIVIDUAL IS AN EMPLOYEE OF A PUBLIC TRANSIT
- 7 AUTHORITY AND IS OPERATING A PUBLIC TRANSIT VEHICLE OR IS PER-
- 8 FORMING DUTIES ASSOCIATED WITH THE OPERATION OF A PUBLIC TRANSIT
- 9 VEHICLE.
