- 1 SEC. 21534. (1) BEGINNING JANUARY 1, 2002, A HOSPITAL SHALL
- 2 SPECIFICALLY NOTIFY IN WRITING A PATIENT OR THE PATIENT'S GUARD-
- 3 IAN OR LEGAL REPRESENTATIVE OF THE AVAILABILITY OR LACK OF AVAIL-
- 4 ABILITY OF HOSPICE CARE IN THE HOSPITAL. THIS WRITTEN NOTICE
- 5 SHALL BE BY WAY OF A SPECIFIC PARAGRAPH LOCATED IN THE ADMISSION
- 6 DOCUMENTS AND SHALL REQUIRE THE PATIENT OR THE PATIENT'S GUARDIAN
- 7 OR LEGAL REPRESENTATIVE TO SIGN OR INITIAL THE PARAGRAPH BEFORE
- 8 ADMISSION TO THE HOSPITAL. FAILURE OF THE HOSPITAL TO SUBSTAN-
- 9 TIALLY COMPLY WITH THE REQUIREMENT IMPOSED UNDER THIS SECTION
- 10 RENDERS THE ADMISSION DOCUMENTS VOIDABLE AT THE OPTION OF THE
- 11 PATIENT OR THE PATIENT'S GUARDIAN OR LEGAL REPRESENTATIVE. THE
