- 17 (C) THE CRIMINAL OFFENSE PRODUCES CONSEQUENCES THAT HAVE A
- 18 MATERIALLY HARMFUL IMPACT UPON THE SYSTEM OF GOVERNMENT OR THE
- 19 COMMUNITY WELFARE OF THIS STATE, OR RESULTS IN PERSONS WITHIN
- 20 THIS STATE BEING DEFRAUDED OR OTHERWISE HARMED.
