THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 CHAPTER XI
- 2 SEC. 2B. (1) THE COURT MAY PLACE AN INDIVIDUAL CONVICTED OF
- 3 A VIOLATION DESCRIBED IN SUBSECTION (4) ON PROBATION FOR ANY TERM
- 4 OF YEARS BUT NOT LESS THAN 5 YEARS.
- (2) IF THE INDIVIDUAL IS PLACED ON PROBATION UNDER THIS SEC-5
- HOUSE BILL No. 5322 6 TION, THE COURT MAY ORDER THE INDIVIDUAL, AS A CONDITION OF PRO-

- 11 (B) "SCHOOL PROPERTY" MEANS A BUILDING, PLAYING FIELD, OR
- 12 PROPERTY USED FOR SCHOOL PURPOSES TO IMPART INSTRUCTION TO CHIL-
- 13 DREN OR USED FOR FUNCTIONS AND EVENTS SPONSORED BY A SCHOOL,
- 14 EXCEPT A BUILDING USED PRIMARILY FOR ADULT EDUCATION OR COLLEGE
