A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding sections 18609 and 18611.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 18609. UPON REQUEST, A PHYSICIAN OR OPTOMETRIST SHALL
- 2 RELEASE A CONTACT LENS PRESCRIPTION TO A PATIENT OR AS DIRECTED
- 3 BY THE PATIENT UNLESS ANY OF THE FOLLOWING APPLY:
- 4 (A) THE CONTACT LENS PRESCRIPTION IS EXPIRED.
- 5 (B) THE PATIENT HAS NOT PAID THE PHYSICIAN OR OPTOMETRIST
- 6 FOR GOODS OR SERVICES PREVIOUSLY RENDERED TO THE PATIENT BY THE
- 7 PHYSICIAN OR OPTOMETRIST.
- 8 (C) THE PHYSICIAN OR OPTOMETRIST MAKES A GOOD FAITH DETERMI-
- 9 NATION THAT GIVING THE PATIENT A COPY OF THE CONTACT LENS
- 10 PRESCRIPTION MAY JEOPARDIZE THE PATIENT'S OCULAR HEALTH. THE
