- 3 SELL NONHALAL MEAT AND FOOD ONLY", OR "WE SELL BOTH HALAL AND

- 5 (3) POSSESSION OF NONHALAL FOOD, IN ANY PLACE OF BUSINESS
- 6 ADVERTISING THE SALE OF HALAL FOOD ONLY, IS PRESUMPTIVE EVIDENCE
- 7 THAT THE PERSON IN POSSESSION EXPOSES THE NONHALAL MEAT AND FOOD
- 8 FOR SALE WITH INTENT TO DEFRAUD.
- 9 (4) A PERSON WHO DOES ANY OF THE FOLLOWING IS GUILTY OF A

- 11 (A) WILLFULLY MARKS, STAMPS, TAGS, BRANDS, LABELS, OR IN ANY
- 12 OTHER WAY OR BY ANY OTHER MEANS OF IDENTIFICATION REPRESENTS OR
- 13 CAUSES TO BE MARKED, STAMPED, TAGGED, BRANDED, LABELED, OR REPRE-

- 6 TIONS AND SHALL ENFORCE THIS ACT. THE DEPARTMENT OF AGRICULTURE
- 7 MAY PROMULGATE RULES FOR THE ENFORCEMENT AND ADMINISTRATION OF
