THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 75. (1) A member who left or leaves service as a

public school employee for purposes of maternity or paternity or

child rearing, and returns to service as a public school employ-

ee, or a person performing out of system public education service

who leaves that service for purposes of maternity, paternity, or

child rearing and who subsequently becomes a member of this

retirement system, without other intervening employment of more

than 20 hours per week for each week for which service credit is

claimed, may purchase service credit for the time period or

periods during which the person was separated from service as a

public school employee or during which the person was separated
