- 1 SEC. 411T. A PERSON SHALL NOT USE THE INTERNET OR A TELE-
- 2 COMMUNICATION SYSTEM OR OTHER ELECTRONIC SYSTEM OR DEVICE SO AS
- 3 TO DISRUPT THE FUNCTIONS OF THE PUBLIC SAFETY, EDUCATIONAL, COM-
- 4 MERCIAL, OR GOVERNMENTAL OPERATIONS OF THIS STATE WITH THE INTENT
- 5 TO COMMIT AN OFFENSE PROHIBITED UNDER CHAPTER LXXXIII-A. A
- 6 PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A FELONY PUNISHABLE
- 7 BY IMPRISONMENT FOR NOT MORE THAN 20 YEARS OR A FINE OF NOT MORE
- 8 THAN \$100,000.00, OR BOTH. AS USED IN THIS SECTION:
- 9 (A) "COMPUTER", "COMPUTER NETWORK", "COMPUTER PROGRAM",
- 10 "COMPUTER SYSTEM", "DEVICE", AND "INTERNET" MEAN THOSE TERMS AS
- 11 DEFINED IN SECTION 145D.
