## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 479C. (1) A PERSON WHO COMMITS ANY ACT OR OMISSION IN
- 2 RECKLESS DISREGARD OF THE SAFETY OF AN EMERGENCY RESPONSE WORKER
- 3 PERFORMING HIS OR HER DUTIES AS AN EMERGENCY RESPONSE WORKER IS
- 4 GUILTY OF A CRIME AS FOLLOWS:
- 5 (A) EXCEPT AS PROVIDED IN SUBDIVISION (B), THE PERSON IS
- 6 GUILTY OF A MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE
- 7 THAN 1 YEAR OR A FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 8 (B) IF THE VIOLATION RESULTS IN PHYSICAL INJURY TO ANY EMER-
- 9 GENCY RESPONSE WORKER, THE PERSON IS GUILTY OF A FELONY
- 10 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
- 11 NOT MORE THAN \$2,000.00, OR BOTH.

- **15** 333.20950.
- 16 (B) "PEACE OFFICER" MEANS ANY OF THE FOLLOWING:
- 17 (i) A POLICE OFFICER OF THIS STATE OR A POLITICAL SUBDIVI-
- 18 SION OF THIS STATE.
- 19 (ii) THE SHERIFF OF A COUNTY OF THIS STATE OR THE SHERIFF'S
- 20 DEPUTY.
- 21 (iii) A PUBLIC SAFETY OFFICER OF A COLLEGE OR UNIVERSITY WHO
- 22 IS AUTHORIZED BY THE GOVERNING BOARD OF THAT COLLEGE OR UNIVER-
- 23 SITY TO ENFORCE STATE LAW AND THE RULES AND ORDINANCES OF THAT
- 24 COLLEGE OR UNIVERSITY.
- 25 (iv) A CONSERVATION OFFICER OF THE DEPARTMENT OF NATURAL
- 26 RESOURCES.
