THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 (1) BEGINNING JANUARY 1, 2003, A COUNTY MAY ASSESS SEC. 4B.
- AN INMATE BOOKING FEE FOR THE PURPOSES DESCRIBED IN THIS 2
- 3 SECTION. BEFORE A COUNTY MAY ASSESS THE FEE, THE COUNTY SHALL DO
- 4 BOTH OF THE FOLLOWING:
- 5 (A) APPROVE THE BOOKING FEE BY RESOLUTION APPROVED BY A
 - MAJORITY VOTE OF THE COUNTY BOARD OF COMMISSIONERS.
 - (B) CREATE A COUNTY CORRECTIONS OFFICERS TRAINING FUND FOR
 - THE DEPOSIT OF REVENUE DERIVED FROM THE BOOKING FEE.
 - (2) IN A COUNTY THAT HAS COMPLIED WITH SUBSECTION (1), EACH PERSON SENTENCED TO A TERM OF IMPRISONMENT IN THE COUNTY JAIL SHALL PAY A BOOKING FEE IN AN AMOUNT DESCRIBED IN SUBSECTION (3),

- 1 WHICH SHALL BE COLLECTED BY THE COUNTY SHERIFF WHEN THE PERSON
