A bill to amend 1846 RS 171, entitled "Of county jails and the regulation thereof," (MCL 801.1 to 801.27) by adding section 4a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 4A. (1) BEGINNING JANUARY 1, 2003, EACH PERSON WHO IS
- 2 INCARCERATED IN A JAIL OR LOCKUP OPERATED BY A CITY, VILLAGE, OR
- 3 TOWNSHIP SHALL PAY A FEE OF \$10.00, WHICH IS PAYABLE TO THE OFFI-
- 4 CER IN CHARGE OF THE JAIL OR LOCKUP WHEN THE PERSON IS ADMITTED
- 5 INTO THE JAIL OR LOCKUP.
- 6 (2) THE OFFICER IN CHARGE OF A JAIL OR LOCKUP WHO RECEIVES
- 7 ANY FEES UNDER THIS SECTION SHALL FORWARD THOSE FEES TO THE
- 8 COUNTY TREASURER FOR THE COUNTY IN WHICH THE JAIL OR LOCKUP IS
- 9 LOCATED. ONCE EACH CALENDAR OUARTER, THE COUNTY TREASURER SHALL
 - FORWARD ALL FEES COLLECTED UNDER THIS SECTION TO THE STATE

- 13 THE COUNTY TREASURER SHALL FORWARD ALL CIVIL FINES COLLECTED
