THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 217K. (1) THE SECRETARY OF STATE SHALL DEVELOP AND
- 2 ISSUE AN "EAGLE SCOUT" FUND-RAISING PLATE. THE SECRETARY OF
- 3 STATE SHALL DESIGN THE PLATE, HAVING THE WORDS "EAGLE SCOUT" AND
- 4 THE VIGNETTE OF THE BOY SCOUTS OF AMERICA INSCRIBED ON THE
- 5 PLATE. THE WORD "MICHIGAN" SHALL APPEAR ON THE PLATE.
 - (2) THE OWNER OF A VEHICLE REQUIRED TO BE REGISTERED UNDER
 - THIS ACT MAY APPLY, ON A FORM PRESCRIBED BY THE SECRETARY OF
 - STATE, FOR AN EAGLE SCOUT REGISTRATION PLATE INSTEAD OF A STAN-
 - DARD REGISTRATION PLATE.
