HOUSE BILL No. 6037

May 8, 2002, Introduced by Rep. Bradstreet and referred to the Committee on Family and Children Services.

A bill to amend 1962 PA 60, entitled

"An act to provide for the day parole of prisoners in county jails to permit them to be gainfully employed outside the jail or pursue other activities; to provide for the granting of reductions in terms of imprisonment and the regulation thereof; and to provide for the disposition of earnings from such employment,"

by amending sections 2, 3, 4, and 6 (MCL 801.252, 801.253, 801.254, and 801.256).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. The sheriff, or friend of the court FAMILY SERV-
- 2 ICES ADMINISTRATOR in alimony or nonsupport cases, shall collect
- 3 the wages or salary of an employed prisoner, or require him THE
- f 4 PRISONER to turn over his OR HER wages or salary in full when
- 5 received. The officer shall deposit the same WAGES OR SALARY
- 6 in a trust checking account and keep a ledger showing the status
