## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 438. (1) FOR THE 2001 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 2001 TAX YEAR, AN INDIVIDUAL MAY DESIGNATE ON HIS OR HER
- 3 ANNUAL RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER
- 4 REFUND BE CREDITED TO THE AMANDA'S FUND FOR BREAST CANCER
- 5 RESEARCH CREATED IN THE AMANDA'S FUND FOR BREAST CANCER RESEARCH
- 6 ACT. IF AN INDIVIDUAL'S REFUND IS NOT SUFFICIENT TO MAKE A CON-
- 7 TRIBUTION UNDER THIS SECTION, THE INDIVIDUAL MAY DESIGNATE A CON-
