## **HOUSE BILL No. 6151**

May 30, 2002, Introduced by Rep. George and referred to the Committee on Transportation.

A bill to amend 1972 PA 106, entitled "Highway advertising act of 1972,"

(MCL 252.301 to 252.325) by adding section 18b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 18B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS

- 7 WHETHER ADVERTISED OR REPRESENTED AS AN ADULT ENTERTAINMENT
- 8 STUDIO, EXOTIC DANCE STUDIO, ENCOUNTER STUDIO, SENSITIVITY
- 9 STUDIO, MODEL STUDIO, ESCORT SERVICE, ESCORT, OR ANY OTHER TERM
- 10 OF LIKE IMPORT.
- 11 (F) "ADULT MINI-MOTION PICTURE THEATER" MEANS AN ENCLOSED
- 12 BUILDING WITH A CAPACITY OF LESS THAN 50 PERSONS REGULARLY USED
- 13 FOR PRESENTING MATERIAL DISTINGUISHED OR CHARACTERIZED BY AN
- 14 EMPHASIS ON MATTER DEPICTING, DESCRIBING, OR RELATING TO A SPE-
- 15 CIFIC SEXUAL ACTIVITY FOR OBSERVATION BY PATRONS IN THE
- **16** ESTABLISHMENT.
- 17 (G) "ADULT MOTION PICTURE THEATER" MEANS AN ENCLOSED BUILD-
- 18 ING WITH A CAPACITY OF 50 OR MORE PERSONS REGULARLY USED FOR
- 19 PRESENTING MATERIAL HAVING AS A DOMINANT THEME OR PRESENTING
- 20 MATERIAL DISTINGUISHED OR CHARACTERIZED BY AN EMPHASIS ON MATTER
- 21 DEPICTING, DESCRIBING, OR RELATING TO A SPECIFIC SEXUAL ACTIVITY
- 22 FOR OBSERVATION BY PATRONS IN THE ESTABLISHMENT.
- 23 (H) "BILLBOARD" MEANS A SIGN SEPARATE FROM A PREMISES
- 24 ERECTED FOR THE PURPOSE OF ADVERTISING A PRODUCT, EVENT, PERSON,
- 25 OR SUBJECT NOT RELATED TO THE PREMISES ON WHICH THE SIGN IS
- 26 LOCATED. OFF-PREMISES DIRECTIONAL SIGNS AS PERMITTED IN THIS ACT

- 6 AROUSAL.
- (ii) AN ACT OR REPRESENTATION OF AN ACT OF HUMAN MASTURBA-7
- TION, SEXUAL INTERCOURSE, SODOMY, CUNNILINGUS, FELLATIO, OR
- 9 EXCRETORY FUNCTION.
- 10 (iii) FONDLING OR EROTIC TOUCHING OF HUMAN GENITALS, PUBIC
- REGIONS, BUTTOCKS, OR FEMALE BREASTS. 11
- 12 (iv) LESS THAN COMPLETELY AND OPAQUELY COVERED HUMAN GENI-
- 13 TALS OR PUBIC REGIONS, BUTTOCKS, OR FEMALE BREASTS BELOW THE TOP
- 14 OF THE AREOLA.
- (v) HUMAN MALE GENITALS IN A DISCERNIBLY TURGID STATE, EVEN 15
- 16 IF COMPLETELY AND OPAQUELY COVERED.
