

# HOUSE BILL No. 6193

June 13, 2002, Introduced by Reps. Raczkowski, Bishop, Koetje, Woronchak, Gilbert and Kowall and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16r of chapter XVII (MCL 777.16r), as amended  
by 2002 PA 279.

### CHAPTER XVII

Sec. 16r. This chapter applies to the following felonies
