June 27, 2002, Introduced by Rep. Meyer and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16d of chapter XVII (MCL 777.16d), as amended  
by 2002 PA 269.
