## **HOUSE BILL No. 6483**

November 7, 2002, Introduced by Rep. Koetje and referred to the Committee on Commerce.

A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 281, 282, 289, and 294 (MCL 168.281, 168.282, 168.289, and 168.294), section 281 as amended by 1999 PA 218, and by adding section 281a; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 281. (1) A person shall not be eligible to IS NOT
- 2 ELIGIBLE FOR membership on the state board of education -, the

- 12 BOARD OF TRUSTEES OF MICHIGAN STATE UNIVERSITY, AND THE BOARD OF
- 13 GOVERNORS OF WAYNE STATE UNIVERSITY FOR AN 8-YEAR TERM.
- 14 (E) AT THE GENERAL NOVEMBER ELECTION IN 2012 AND EVERY SUB-
- 15 SEQUENT EVEN-YEAR GENERAL NOVEMBER ELECTION, A DISTRICT THAT HAS
- 16 PREVIOUSLY ELECTED A MEMBER OF THE BOARD OF REGENTS OF THE
- 17 UNIVERSITY OF MICHIGAN, THE BOARD OF TRUSTEES OF MICHIGAN STATE
- 18 UNIVERSITY, AND THE BOARD OF GOVERNORS OF WAYNE STATE UNIVERSITY,
- 19 WHOSE 8-YEAR TERM EXPIRES ON THE JANUARY 1 FOLLOWING THAT GENERAL
- 20 NOVEMBER ELECTION, SHALL ELECT A MEMBER TO THE BOARD OF REGENTS

- 24 (4) THE TERM OF OFFICE OF A MEMBER OF A BOARD DESCRIBED IN

- 26 OR HER ELECTION AND CONTINUES UNTIL A SUCCESSOR IS ELECTED AND
- **27** QUALIFIED.

- 1 (5) A PERSON IS NOT ELIGIBLE FOR ELECTION TO A BOARD
- 2 DESCRIBED IN THIS SECTION FROM A DISTRICT IF THE PERSON IS NOT A
- 3 REGISTERED AND QUALIFIED ELECTOR OF THAT DISTRICT ON THE DATE THE
- 4 PERSON IS NOMINATED FOR THE OFFICE.
- 5 (6) A PERSON WHO HAS BEEN CONVICTED OF A VIOLATION OF SEC-
- 6 TION 12A(1) OF 1941 PA 370, MCL 38.412A, IS NOT ELIGIBLE FOR MEM-
- 7 BERSHIP ON A BOARD DESCRIBED IN THIS SECTION FOR A PERIOD OF 20
- 8 YEARS AFTER CONVICTION.
- 9 Sec. 282. (1) SUBSECTION (2) APPLIES UNTIL THE GENERAL
- 10 NOVEMBER ELECTION IN 2004. SUBSECTION (3) APPLIES TO THE GENERAL
- 11 NOVEMBER ELECTION IN 2004 AND THEREAFTER.
- 12 (2) At its fall state convention each political party may
- 13 nominate 2 candidates for membership on the board of regents of
- 14 the University of Michigan, 2 candidates for membership on the
- 15 board of trustees of Michigan State University and 2 candidates
- 16 for membership on the board of governors of Wayne State
- 17 University. Nomination to membership on the board of regents of
- 18 the University of Michigan shall occur in 1966 and every second
- 19 year thereafter. Nomination to the board of trustees of Michigan
- 20 State University and to the board of governors of Wayne State
- 21 University shall occur in 1964 and every second year thereafter.
- 22 (3) AT ITS FALL STATE CONVENTION PRECEDING A GENERAL
