A bill to amend 1954 PA 116, entitled "Michigan election law,"

(MCL 168.1 to 168.992) by adding section 659.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 659. (1) IF A CITY, WARD, TOWNSHIP, OR VILLAGE IS
- 2 DIVIDED INTO 2 OR MORE ELECTION PRECINCTS, THE CITY, WARD, TOWN-
- 3 SHIP, OR VILLAGE ELECTION COMMISSIONERS MAY, BY RESOLUTION, CON-
- 4 SOLIDATE THE ELECTION PRECINCTS FOR A PARTICULAR ELECTION THAT IS
- 5 NOT A GENERAL NOVEMBER ELECTION, A PRIMARY ELECTION IMMEDIATELY
- 6 BEFORE A GENERAL NOVEMBER ELECTION, OR OTHER STATEWIDE OR FEDERAL
- 7 ELECTION. IN MAKING THE DETERMINATION TO CONSOLIDATE ELECTION
- 8 PRECINCTS FOR A PARTICULAR ELECTION, THE ELECTION COMMISSION
- 9 SHALL TAKE INTO CONSIDERATION THE NUMBER OF CHOICES THE VOTER
- 10 MUST MAKE, THE PERCENTAGE OF REGISTERED VOTERS WHO VOTED AT THE
- 11 LAST SIMILAR ELECTION IN THE JURISDICTION, AND THE INTENSITY OF

- 15 ING PLACE FOR THE ELECTION PRECINCT OR PRECINCTS FOR THAT
- 16 ELECTION. NOTICE MAY BE PROVIDED BY MAIL OR OTHER METHOD
- 17 DESIGNED TO PROVIDE ACTUAL NOTICE TO THE REGISTERED ELECTORS.
- 18 (B) POST A WRITTEN NOTICE AT EACH ELECTION PRECINCT POLLING
- 19 PLACE STATING THE LOCATION OF THE CONSOLIDATED ELECTION PRECINCT
- 20 POLLING PLACE.
- 21 (4) IF A CITY, WARD, TOWNSHIP, OR VILLAGE CONSOLIDATES ELEC-
- 22 TION PRECINCTS UNDER THIS SECTION, EACH AFFECTED ELECTION PRE-
- 23 CINCT SHALL BE TREATED AS A WHOLE UNIT AND SHALL NOT BE DIVIDED
- 24 DURING THE CONSOLIDATION.
