THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 509u. (1) Not later than the thirtieth day after the
- 2 effective date of this section FEBRUARY 9, 1995, the governor
- 3 shall provide a list to the secretary of state designating the
- 4 executive departments, state agencies, or other offices that will
- 5 perform voter registration activities in this state.
- 6 (2) Pursuant to the national voter registration act of 1993,
- 7 a recruitment office of the armed forces of the United States is
- 8 a designated voter registration agency under this act.
